ALTERATION OF BOUNDARIES —
THE TOWN OF BREDENBURY AND THE RURAL
MUNICIPALITY OF SALTCOATS NO. 213

1 Pursuant to sections 53, 56, 57, 59 and 61 of *The Municipalities Act*, the Council of the Town of Bredenbury has submitted an application to alter its boundaries to the Minister of Government Relations.

2 Upon consideration of the application, the Minister is of the opinion that the municipalities affected will be viable entities following the alteration of boundaries. Therefore, the undersigned hereby orders, pursuant to sections 61, 62 and 63 of *The Municipalities Act*, that:

(a) the boundaries of the Town of Bredenbury and the Rural Municipality of Saltcoats No. 213 be altered by withdrawing from the rural municipality and adding to the town the territory described in Schedule A;

(b) Schedule B is conclusively deemed to be the legal description of the boundary of the Town of Bredenbury; and

(c) the alteration shall take effect on and from the date of this Order.

SCHEDULE A

The boundaries of the Town of Bredenbury are altered by adding to the town and withdrawing from the Rural Municipality of Saltcoats No. 213, all that portion of road allowance lying adjacent to the easterly limit of the south-east quarter of Section 35, Township 22, Range 1, West of the Second Meridian, lying south of the southerly limit of the Canadian Pacific Railway right of way as shown on Plan No. 39669 and north of the northerly limit of highway Plan No. 71Y07834.

SCHEDULE B

The boundaries of the Town of Bredenbury shall comprise the territory in the Province of Saskatchewan lying within:

Township 22, Range 1, West of the Second Meridian and described as:

- (1) legal subdivisions 1, 8, 9 and 16 of Section 34; and

CERTIFICATE OF EXEMPTION —
ADM AGRI-INDUSTRIES COMPANY

Subsection 23(3), section 23.1, subsection 25(1), sections 26, 28 and 34 of the Act shall continue to apply the Rail Operations.

4 Accidents and Reports

Subsections 31(2), (3) and section 32 of the Act shall continue to apply to the Rail Operations.

5 Offence and Penalty

Section 52 of the Act shall continue to apply to the Rail Operations with respect to a violation of any provision of the Act referred to in clauses (c) and (d) hereof.
